CHARITY COMMISSION

In the matter of the Charity called The GRAMMAR SCHOOL, in the Parish of BISHOP STORTford, in the County of HERTFORD; and
In the matter of “The Charitable Trusts Act, 1853 to 1894”

The Board of Charity Commissioners for England and Wales, being satisfied by the representations of the Trustees of the above-mentioned Charity, that it will be advantageous to the said Charity that the sale of the here ditaments described in the Schedule hereto, should be effected upon the terms herein-after mentioned:

Do, upon the application of the said trustees, **hereby order** as follows:-

1 The trustees may, within six months from the date of this order, sell the said hereditaments for not less than £160 and may also do and execute all proper acts and assurances for carrying the said sale into effect, subject to the condition that all the costs charges, and expenses attending or incidental to the said sale, including the costs of the deduction and verification of any title which may be required to be shown to the premises, shall be paid by the purchaser

2. “The official Trustee of Charity Lands,” in whom the legal estate in the premises is vested in trust for the

said Charity, shall concur in the conveyance thereof
if his concurrence is required

3. The purchase money, when received by the said Trustees, shall be held by them subject to the further Order of the said Board.

This Indenture is made the twelfth day of April one thousand eight hundred and ninety eight **Between** Daniel Robert Fearon Esquire C.B. the Secretary for the time being of the Board of Charity Commissioners for England and Wales and as such The Official Trustee of Charity Lands hereinafter called "The Official Trustee" of the first part The Reverend Henry Tydd Lane Vicar of Bishops Stortford John Dobede Fairman Robert Cole Arthur Woodham Nash Henry Baker Charles Frederick Hodson John Edward Morris Thomas Nottage Miller William Smith George Speechly Alfred Taylor John Slack Taylor and Marshall Taylor being the Trustees of the Charity known as The Grammar School and Library Estate at Bishops Stortford aforesaid and Reginald Geare the Headmaster of the said school of the second part and Sir Walter Gilbey of Elsenham Hall in the County of Essex Baronet of the third part **Whereas** the parties hereto of the second part hereinafter referred to as "The Trustees" are the duly constituted Trustees of the said Charity **And whereas** by an Order made by the said Board on the seventh day of March One thousand eight hundred and eighty two the legal estate in the hereditaments intended to be hereby conveyed was vested in the Official Trustee In trust for the Charity **And whereas** by an order made by the said board on the second day of November One Thousand eight hundred and ninety seven The Trustees were authorized within six months from the date thereof to sell the hereditaments described in the Schedule thereto (being the hereditaments hereinafter mentioned and intended to be hereby conveyed) for not less than one hundred and sixty pounds and to do and execute all proper acts and assurances for carrying the said sale into effect and the Official Trustee was ordered and directed to

concur in the conveyance of the said hereditaments if his concurrence should be required **Now this indenture witnesseth** that in consideration of the sum of **one hundred and sixty pounds** paid to the trustees by the said Sir Walter Gilbey for the purchase of the said hereditaments (the receipt of which the Trustees hereby acknowledge) **The said** Daniel Robert Fearon pursuant to the Order and direction given to the Official Trustee by the last recited Order and at the request of the Trustees testified by their execution hereof hereby conveys and the Trustees **as Trustees** hereby convey and confirm to the said Sir Walter Gilbey **All that** annuity or yearly sum of five pounds charged upon and issuing out of certain malt shops situate in the Timber Mead in the parish of Bishops Stortford and now or late the property of the Proprietors of the Stort Navigation **To hold** to and **To the use** of the said Sir Walter Gilbey in fee simple **In witness** whereof the said parties to these presents have hereunto set their hands and seals the day and year first before written
